The Great Road Trip

■ In part one, Hal and Evelyn drive to Michigan for his 50th high school reunion.

The postcard arrived almost a year ago. It announced that my 50th high school reunion was scheduled for the last weekend in September. I graduated from Eastern High School in Lansing, Mich. in June 1958. After I left for college, I never lived in Lansing again and, while I did visit a few times, I have not seen anyone from my high school class since graduation.

After I talked to Evelyn, we decided to go to the reunion and make a road trip out of it. At first I thought about flying to Lansing and then renting a car and driving back to California. After I found out that the drop-off charge would be close to \$1,000, we decided to take our own car and drive both ways.

I had always wanted to visit Mount Rushmore and the Little Big Horn Memorial, so we knew that we would drive back to Los Angeles by a northern route. Getting to Lansing was more of a drive than a sightseeing opportunity, but we

wanted to see places we had not visited and also see some friends and relatives along

My first choice was to drive through Las Vegas and then stop in Colorado Springs to stay at the Broadmoor Hotel and then go through Kansas City, St. Louis and Chicago before reaching Lansing. After laying out the schedule, I tried to make a reservation at the Broadmoor but found that it was fully booked. Because of this, I decided to change our drive to a more southern route.

We planned on being gone for three weeks and we would cover just more than 6,000 miles.

I knew we had to be in Lansing by Sept. 26 so I used Google maps to determine the best routing and the distance between points. I planned to do between 400 and 500 miles per day on the way to Lansing. We also wanted to spend two days in Kansas City and two days in Chicago.

Leaving Los Angeles on Sept. 17 gave us nine days to travel the almost-3,000 miles

Our drive to Lansing would take us through Sedona, Ariz.; Santa Fe, New Mexico; Oklahoma City; Kansas City, Kan., for two nights; Champaign, Ill.; Chicago for two nights; and then to Lansing. We had friends to visit in Kansas City and cousins to visit in Champaign and Chicago. We would spend three nights in Lansing, to go to the reunion and to see friends who didn't go to my high school.

We would leave Lansing Sept. 28th for the return trip. The route back would be through Charlevoix, Mich.; Mackinaw Island, Mich.; Green Bay, Wisc.; Sioux Falls, S.D.; Rapid City, S.D.; Hardin, Mont.; Red Lodge, Mont.; Yellowstone National Park; Jackson Hole, Wy;, Las Vegas; and then home.

We belong to the Automobile Club of Southern California, so I used its Website

to prepare an overall map of the trip and individual trip tickets for each day. Once I had the detailed route, I used the Internet to find a hotel for each night. Except for Chicago, I didn't want to stay in the downtown area and looked for places close to the Interstate. Evelyn had been to Red Lodge before and she wanted to stay at the Pollard Hotel. We ended up at Comfort Inn and Suites, Super 8s, Hilton Garden Inns, Fairfield Inns, and a few local places in Sedona, Jackson Hole and Chicago. In Lansing, we stayed at the Marriott in East Lansing. I made advance reservation at all the motels and hotels.

After everything was completed, I prepared a binder that had the trip tickets and the confirmations from the motels and hotels. I also had the travel books for each state from the Auto Club. I didn't start out with a set of old fashioned folding state maps, which we found to be very useful after we picked up them up in Green Bay.

Our vehicle of choice was GMC Envoy XL. We thought about driving Evelyn's Corvette, but she would have had to leave most of her shoes at home. With the Envoy we had lots of room, though we managed to full it up.

I was a little worried about the price of gas. The Envoy gets about 20 m.p.g. on the highway, but by the time we left, gas prices had begun to fall. I had the car serviced before we left, and I also purchased an electric refrigerator that plugged into the Envoy's 12-volt system. I bought a case of water from Costco, Evelyn packed a bunch of snacks, and we were ready to roll.

We had our laptop with us and of course our cell phones, too. The Envoy has the OnStar system, and I purchased 100 minutes of phone time just in case our phones didn't have service. I used the laptop to keep a daily log of our trip, and Evelyn also kept a journal. I've decided to use the log to tell the story of our trip. So here goes:

Day 1 - Sept. 17

We are on our way to my 50th high school (Eastern High) in Lansing, Mich. We will be gone more than three weeks and will pass through 13 states.

We left home at about 7:30 a.m. heading for our first stop, which is Sedona, Ariz. We are traveling on the I-10 and will drive almost 500 miles today.

Evelyn and I decided that we would share the driving and I was on first. At our

first stop at Blyth to fill up with gas, Evelyn took over the driving all the way to Sedona. Once we reached Phoenix, we headed north on I-17 toward Sedona, about 100 miles from Phoenix.

We got to Sedona around 3 p.m. The drive up from Phoenix is very picturesque. Driving into town was difficult because they are working on widening the highway. It has been going on for two years and has one more year to go.

The area around Sedona reminds me of Red Rock in Las Vegas, but on a much larger scale.

We found our hotel (Sedona Real Inn and Suites) without a problem; I am using the GPS in the Envoy and also have triptickets from the Auto Club. Because they sometimes don't agree, I am using the one with the shortest route. This is where having a paper road map would have helped.

After we checked in, we drove around and stopped at a number of artist galleries and shops. Evelyn brought a few things for the grandkids.

That evening, we had dinner at the Barking Frog, a Mexican cantina. Food was good and the margaritas even better.

I think we will come back to Sedona. It is really an easy drive from LA. There are a lot of things to do for the family.

Day 2 - Sept. 18

After the "deluxe Continental breakfast" – a good example of exaggerating a marketing phrase – we hit the road about 8:30 a.m. for Santa Fe, N.M. The ride out of Sedona to I-40 is on a 28-mile very winding road, but really a great drive. It has great camera overlooks so you can pull off the two-lane road and really enjoy the views. There are also a number of camping sites and lodges along the way. It brings you out on I-40 at about Flagstaff. It is worth the extra time.

I gassed up in Sedona, so we were good to go. Evelyn had never been to the Petrified Forest National Park, about 110 miles east of Flagstaff, so we drove the 28-mile loop from the west entrance to the east entrance. I had been there a couple of years ago, but I saw a lot of things I missed the first time. I was able to use my National Park Golden Age pass, so we didn't have to pay the entrance fee.

It was getting late, so we stopped for lunch in Gallup N.M. While both Arizona and New Mexico are on Mountain Time, Arizona doesn't go on daylight saving time and is the same time as LA, so we lost an hour in New Mexico.

At Albuquerque, we headed north to Santa Fe, the capital of New Mexico, and the oldest continuous capital city in the United States. We got to the Comfort Suites, which is much nicer than the Sedona Real, and checked in.

We drove to the old town area of Santa Fe and walked around a bit, but much of the shops close at 6 p.m. We weren't too hungry, but we found the Blue Corn Café and had a bite to eat and drink. I'm sorry we didn't have more time here, and I guess we will have to come back.

Today we traveled just under 500 miles. Tomorrow we head to Oklahoma City.


